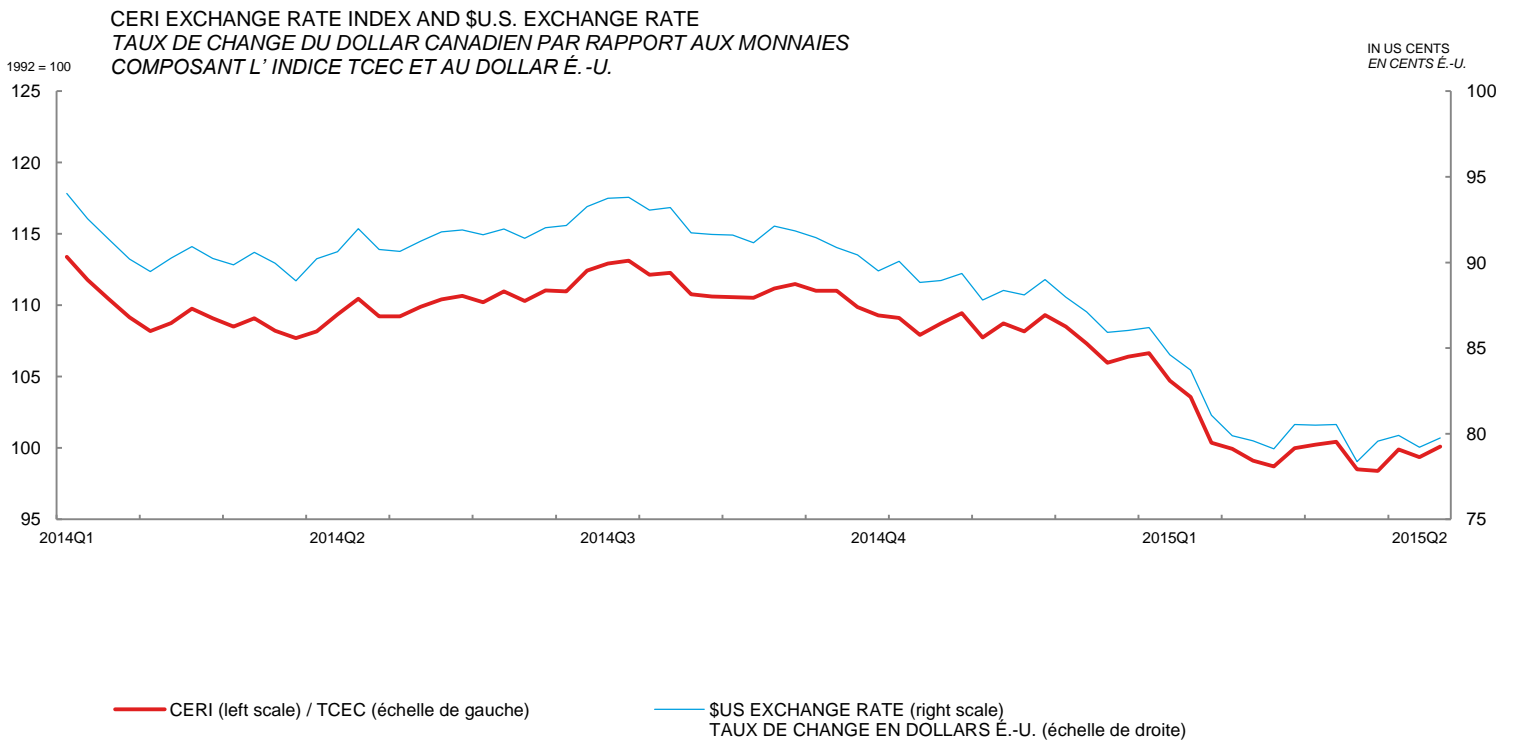
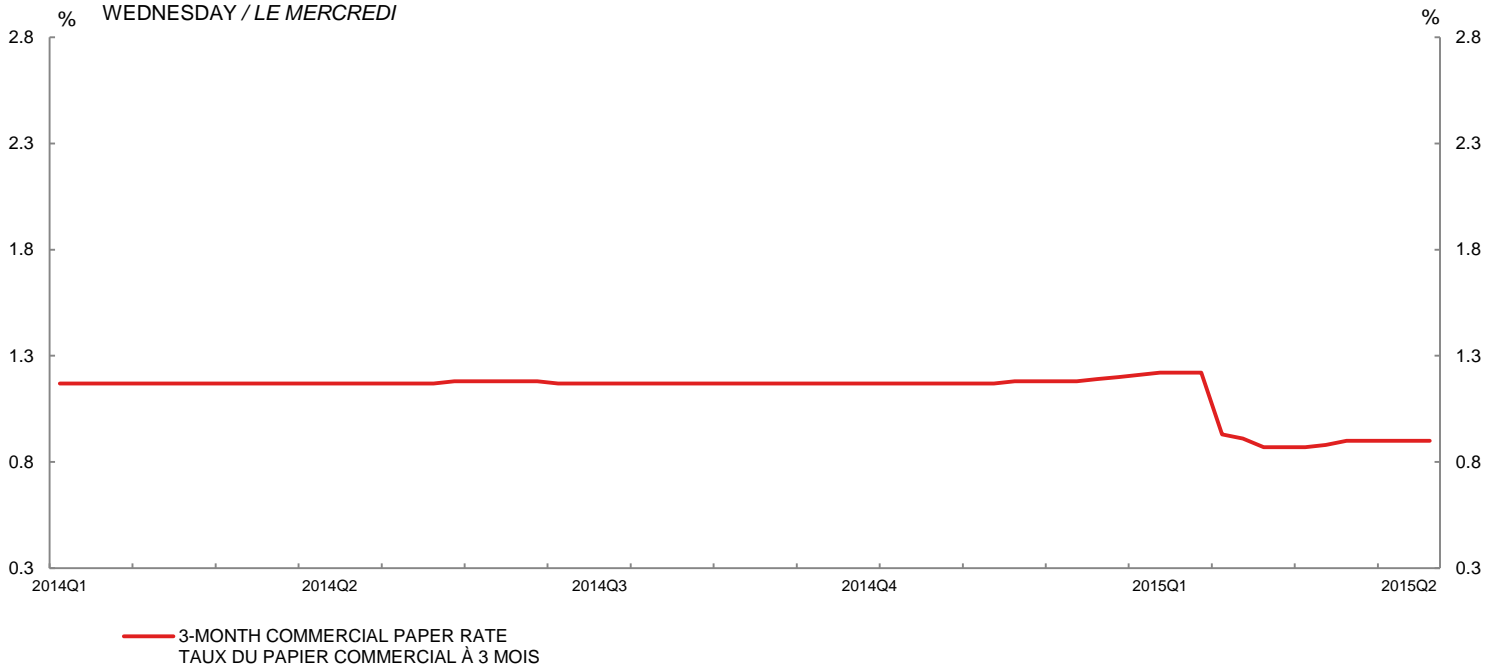
CANADA- U.S. 3-MONTH COMMERCIAL PAPER RATE

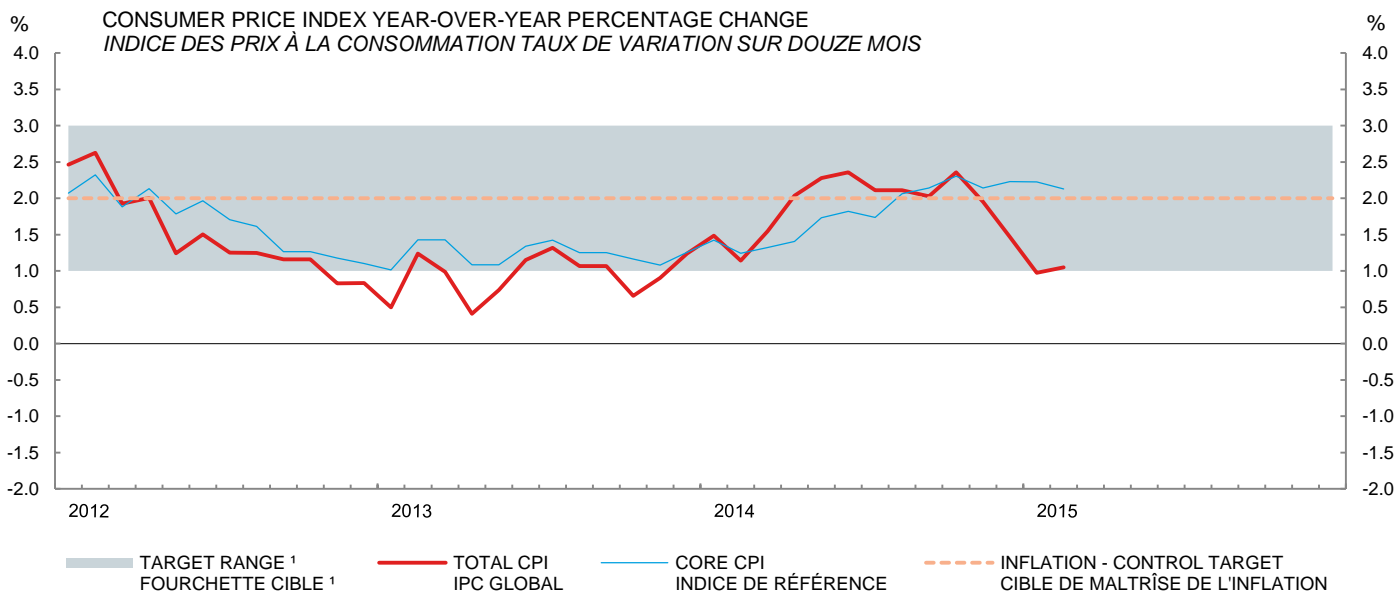
