

# Senior Loan Officer Survey

on Business-Lending Practices in Canada

Results of the Second-Quarter 2011 Survey

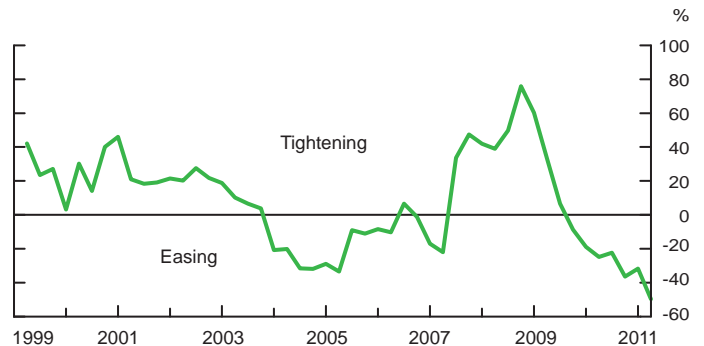

This *Senior Loan Officer Survey* (SLOS) focused on changes to business-lending practices in the second quarter of 2011.

- The survey results point to an overall net easing in business-lending conditions (**Chart 1**). The balance of opinion regarding both price and non-price lending conditions showed the greatest degree of consensus on easing since the survey began in 1999 (**Chart 2**). Note that the balance of opinion indicates only the direction of the change in lending conditions; it does not provide information on the magnitude of the change.
- The easing in lending conditions continues to spread across borrower categories. Lending conditions for corporate borrowers eased for the eighth consecutive quarter. For commercial borrowers, the survey results indicate a net easing for the fifth consecutive quarter, while for small businesses, overall lending conditions improved for the third quarter in a row. For commercial and small-business borrowers, the balance of opinion showed the greatest degree of consensus on easing since the survey began.
- Respondents continued to consider heightened competition among lenders, a more favourable economic outlook and improved industry-specific conditions as the key factors underlying the easing in lending conditions.
- The balance of opinion regarding the demand for credit from financial institutions increased modestly during the second quarter. The net increase was observed primarily for small-business borrowers and was related to increased financing for “general purposes.”

**Chart 1: Lending conditions continued to ease for Canadian non-financial firms . . .**

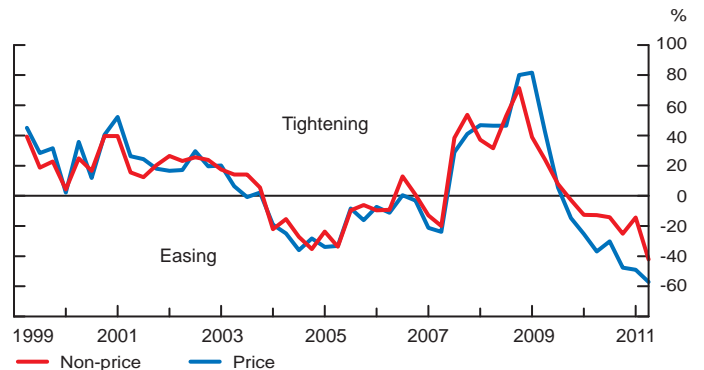
Overall business-lending conditions: Balance of opinion\*



\* The balance of opinion is calculated as the weighted percentage of surveyed financial institutions reporting tightened credit conditions minus the weighted percentage reporting eased credit conditions. Thus, a positive balance of opinion implies a net tightening. The chart shows the average of the balances of opinion for the price and non-price dimensions of lending conditions.

Note: Each series is the simple average of the balances of opinion for the small business, commercial and corporate sectors.

The *Senior Loan Officer Survey* collects information on the business-lending practices of major Canadian financial institutions. In particular, the survey gathers the perspectives of respondents on price and non-price terms of business lending and on topical issues of interest to the Bank of Canada. The survey is conducted quarterly, near the end of the quarter for which the results are reported. The second-quarter survey was conducted between 13 and 16 June 2011.
